## **Objectives and investment policy**

The Fund aims to achieve capital growth over the long term (5 years plus) and will invest at least 80% in shares of Chinese companies.

These are companies which are quoted and listed on Chinese Stock Exchanges, including in A-Shares and B-Shares of such companies or which have their headquarters or a significant part of their activities in China but which are quoted on a regulated market elsewhere, as well as others which are, in the Investment Manager's opinion, Chinese businesses.

The Fund may also invest in:

- transferable securities (including but not limited to shares and bonds issued by governments and other organisations)
- cash deposits and money market instruments
- warrants
- other investment funds

The Fund may be invested in any industry sector with the Investment Manager's focus on growth companies expected to deliver increasing revenue and profit from the expansion of their business over the medium to long term.

As part of its investment process, the Investment Manager integrates environmental, social and governance ("ESG") factors into its routine analysis.

Any income the Fund generates will be re-invested.

You can buy and sell shares Monday to Fridays excluding UK public and bank holidays.

The Fund may use derivatives for efficient portfolio management (EPM), i.e to protect against market or currency movements, to reduce cost or to earn income or capital.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.
