


OUR INVESTMENT PROCESS

We believe in achieving long-term positive returns (after inflation) by investing in diversified, multi-asset portfolios, which are designed to produce attractive risk-adjusted returns.

*** Factor/Smart Beta** strategies choose securities from an index. These are based on specific attributes such as Quality, Value and Minimum Volatility. They also combine the lower cost and rules-based approach of passive investing with the targeted attributes of active investment.
