MANAGER'S COMMENTARY

The Fund has had another good month with the net asset value rising by 4% which compares favourably with a gain of 2.6% in the MSCI AC World Index, against which our performance is judged. For the first six months of the year the net asset value has risen by 10.1%, which again stands handsomely against a gain of a mere 0.5% in the same benchmark.

It was a quiet month, since we are between quarterly earnings reporting periods, and the outperformance was driven by solid gains from all regions, with 27 out of the portfolio's 33 holdings rising, and none declining significantly. Furthermore, no material changes were made to the portfolio in June. **VusionGroup**, the French maker of electronic shelf labels for retailers, announced a significant new contract with Co-op to supply and equip its 2,400 stores. This is the largest UK order to date, while two other pilot projects are also being run with British retailers. The shares gained 20.6% on this cheerful news. Chinese mobile telephone maker **Xiaomi**, which also makes electric cars, launched a new model which was very enthusiastically received, sending the shares almost 18% higher. **Interglobe Aviation**, India's leading airline gained 11.8% over the month as it continues to increase its market share. **Bharti Airtel**, (India, telecoms), also had a good month with the shares ending June 8% higher, while in Europe, **SPIE** and **Safran** both had a solid month, rising by 6.7% and 5.5%, although **Rheinmetall** met some profit taking and fell by 4.4%.

The Fund's holdings in America put in a very strong showing. That said, **Chewy**, the supplier of all manner of pet products, reported some mixed results with strong sales and slightly disappointing margins. However, guidance was quite positive, and the shares shed a mere 5.8%. **Spotify**, **Broadcom**, (semiconductor design), and **Netflix** all had a very good month, each rising by more than 10%. Fortunately, **Tesla's** launch of driverless taxis went badly, with a number crashing and suffering damage. This was helpful for **Uber** whose shares gained 11%. **Comfort Systems**, one of America's leading HVAC contractors, and one of the Fund's longest standing and most successful holdings, rose by another 12% as brokers updated their estimates and upgraded the stock.

World markets have come through another period of geopolitical instability, (although these periods are so frequent now as to be almost unremarkable), entirely unscathed. The oil price flickered higher due to the conflict in Iran, but could not sustain those levels, and remains in a downtrend, while gold has cooled a little, (although it is still in a strong uptrend), and US bond yields have declined slightly. The US dollar has continued to weaken quite significantly, which should be good news for emerging economies, since it allows monetary easing and increased liquidity, while lower oil prices also provide a massive boost for developing countries in Asia. With around 15% of the portfolio in India and South East Asia, we hope to be on the right side of this dynamic.

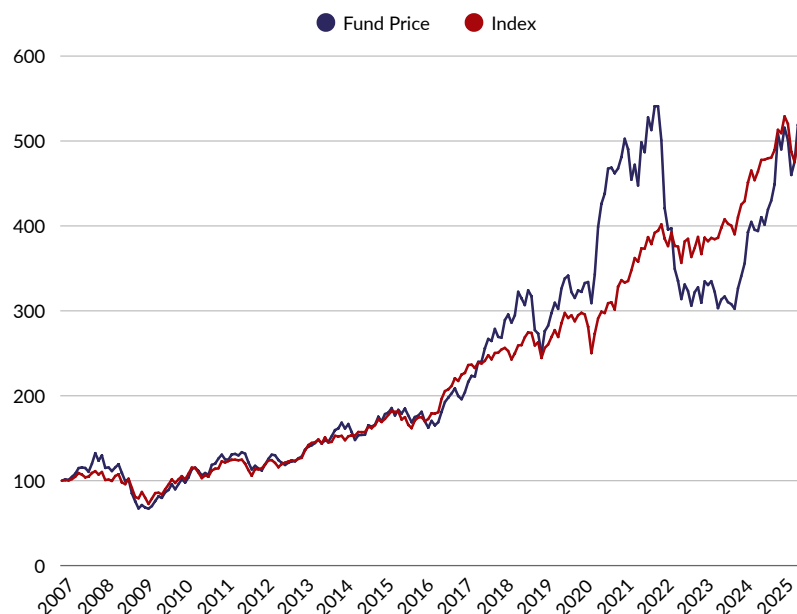

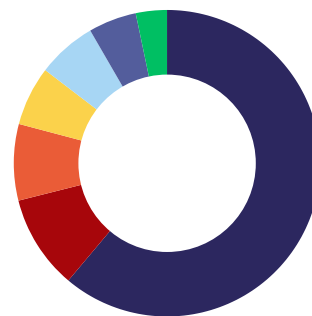
